## Standardisation for the implementation of the Online Access Act in the context of higher education institutions

The Online Access Act (OZG) orders all German higher education institutions to offer their students services digitally for the citizens by 2022. In order for the implementation to succeed, data exchange between the higher education institutions must be standardised wherever possible. The goal is to prevent discontinuity in media when it comes to application procedures. The requirement for reaching the goal is for IT-systems to be able to work together (Interoperability). Together we will develop an interoperability standard, which will provide a basis for data exchange without media discontinuity.

# Introduction

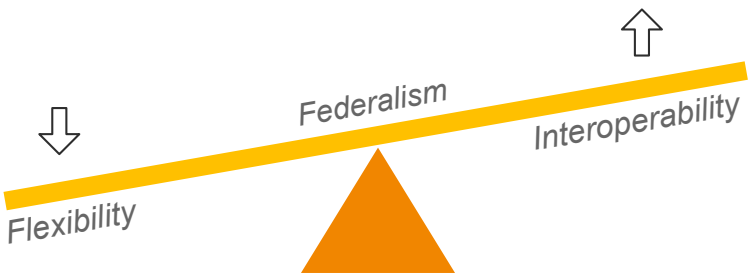

Be part of the journey to the harmonisation of data exchange between higher education institutions.

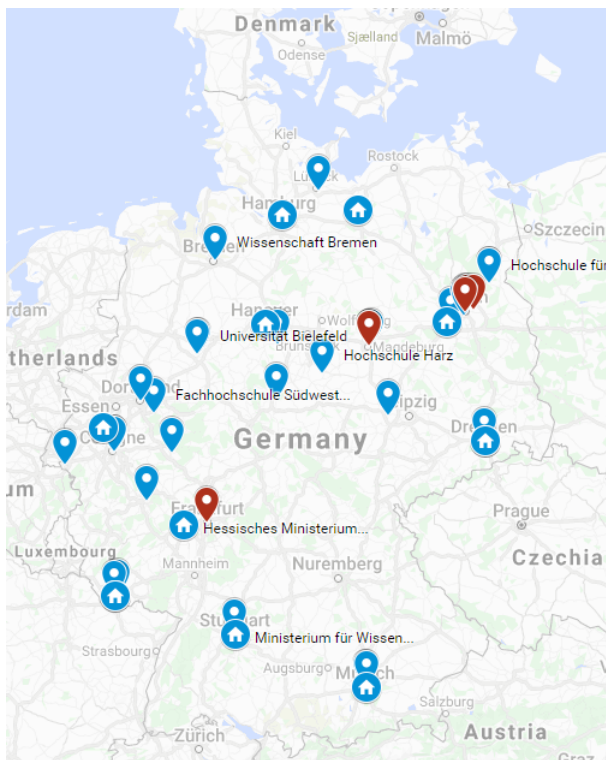
Join us in finding a solution for conciliating as much federalism, autonomy of universities and flexibility as possible, with as much interoperability as possible.

# Crucial points for developing the standard “XHochschule“

---

We recommend compliance with the following principles:

- Consideration of the administrative system (Federal States, Universities, Federal Ministries, etc.)
- Broad and open participation whenever possible (e.g. public participation process, call for comments)
- Consideration of the tight time frame (Deadline for implementation until the end of 2022)
- Ensuring interoperability and utilisation of established standards (e.g. XÖV, XInneres)
- Integration of established OZG-components (e.g. Nutzerkonto, ePayBL)
- Integration of European projects (e.g. Platform for International Student Mobility - PIM, Erasmus without Paper, European Student Card, Europass)
